LONDON – GAC Opening Plenary Session Saturday, June 21, 2014 – 14:00 to 14:30 ICANN – London, England

CHAIR DRYDEN:

Good afternoon, everyone.

Let's get started.

Welcome to London. This will be the room for the GAC throughout our meetings this week. We'll all be getting lots of exercise on the stairs. So maybe that's a good thing. Yeah.

But as you can see, we have a full house. We are aware that there is a shortage of seating, and, therefore, microphones as well for you. So we will see what we can do to address that overnight so that everyone can be comfortably seated in the center.

In the meantime, we do have roving microphones, so if you are not able to sit in the center and you wish to speak, there will be no obstacle to your doing that. We will ensure that a microphone is brought to you so that you can intervene in the discussions.

Okay. So a few other points on logistics. As has become the standard for our meetings, we have interpretation available in the U.N. six languages plus Portuguese. And again, we will have interpretation for all of our meetings this week.

We also will have recordings of our sessions and scribing. And the transcripts are taken at the end of our meetings and are also translated into the U.N. six languages plus Portuguese. So this is how we will record our discussions this week.

Note: The following is the output resulting from transcribing an audio file into a word/text document. Although the transcription is largely accurate, in some cases may be incomplete or inaccurate due to inaudible passages and grammatical corrections. It is posted as an aid to the original audio file, but should not be treated as an authoritative record.

So with those logistical points addressed, let's begin to move through our agenda. There are hard copies available of the agenda, and most of the materials, so you should have copies of those.

If you are missing a copy of anything, if you can go to the table at the back, and, Julia, if you could just wave. There we are. There's Julia. Julia would be happy to help you find whatever document or reference that you are, in fact, seeking.

One document that we are waiting for is in relation to the IGO protections and Red Cross/Red Crescent protections. A letter was recently sent to the GAC list for our information. It's really a letter going from the NGPC to -- to the GNSO asking them to look at some particular areas where a difference in views has been found. So that will be a really useful letter for us to refer to when we get to agenda item number 2.

Okay. So let's come back to agenda item 1, and the first item, which is an update from the chair and vice chairs.

We have not a great deal to report, but one thing that we thought would be useful for colleagues to be aware of are some of the meetings and activities that the chair and vice chairs are involved in throughout the week. So I'll start and give the example of the ATLAS meetings. For anyone not familiar with ATLAS, it is a summit organized by the at-large community here at ICANN which represents users, Internet users, and they're having a summit while we are here in London. So there is a lot of activity this week, and we will do our best to manage that.



So they are looking for the chairs of the SOs and ACs to come and say a few words to meet with participants in ATLAS. So I will be doing that Tuesday morning. And this way we can keep our relationships strong with other parts of the community. And there are various issues where I'm engaged dealing with the other SOs and ACs, the other supporting organizations and advisory committees. And that's an ongoing area of activity so I will report on that as we deal with various issues to try and give you a sense of what those activities are and the content of those discussions.

I will say that currently there is a very robust discussion happening between the SOs and ACs and ICANN's leadership on the issue of overload, workload. Too much happening, how do we keep up, how do we address the problem. And this is one I think we should really embrace and contribute to. It's something that has been troubling me for some time. And I know you are all feeling the consequences of that, trying to prepare for meetings and influence issues and processes that are under way that are of priority to government colleagues here.

So with that, I will turn next to one of the vice chairs, Tracy from Trinidad and Tobago to report on some of the things you have been doing in your capacity as a vice chair.

TRACY HACKSHAW:

All right, thank you, Heather, and good afternoon, everyone. There are two activities that I'm involved in outside of the GAC meetings. This week I'll be speaking, as I have been over the last few meetings, at the Fellowship program. There's a very robust Fellowship program, for those that are not aware, that meets every morning at 7:00 a.m., and all



the community executives meet with them to share their experiences as well as to share what's going on in the community for that meeting. So that will be happening Tuesday at 7:00 a.m.

Also, I've been involved in the cross-community working group that's currently being chartered and those meetings have been ongoing over the last six months up to NETmundial and thereafter. So that's been happening and a progress report will be do perhaps after the charter is sorted out and I will report on that perhaps at the next meeting.

Thank you.

Peter?

PETER NETTLEFOLD:

Thank you, Chair. And welcome, everyone. The update I was going to give relates to the work of the new gTLDs working group. As we all know, this working group is looking at some issues that arose in the first round of new gTLDs, particularly relating to community names, geographic names, and developing country support issues. And I was invited to participate in a cross-community session at this series of meetings. It's at 10:00 a.m. on Wednesday morning and it's looking at the current round of new gTLDs. It's being co-organized by the Registry Stakeholder Group and the New TLD Applicant Group, and I was invited to provide a GAC perspective on the current round.



So I intend to use this opportunity to inform the community of the GAC's work through the New gTLD Working Group and to encourage some coordination between different efforts, which I expect are going on in different parts of the community to prepare for future rounds. But as yet, I've not seen a great deal of coordination.

So if anyone would like to discuss that with me in advance of that session, I'd be happy to chat, and I will certainly report back on any outcomes from that. As I say, I think it's a great opportunity, particularly following the GAC session earlier on the Wednesday morning where the geographic names subgroup will be presenting to the community on the GAC's work in this area to go straight into a session with the community more broadly.

So I think it's a very useful opportunity.
